1. Welcome and Introductions.

Brenda Pankoff, President

On behalf of the Board of Directors and staff of the MBAO, I would like to thank you for attending our AGM this morning and for your ongoing interest and input into our association.

I would like to take this opportunity on behalf of our membership to thank Dave Johnson, our Director of Operations for his work on behalf of our association this past season. Our Tournament Director Henry Fehr assists Dave with tournament preparation and delivery and his efforts are much appreciated. Walter Heeney continues to work on marketing our association and this past year, we also had a student, Ashleigh Maisels from Seneca College who helped with this as well as some administrative tasks in the office.

This AGM allows us an opportunity to reflect back on this years events as well as to plan for our future. Unfortunately, the number of bowling centres continues to decline and with this both youth membership and adult membership. This past season, we also saw a decline in our membership numbers by 19. Some of this may be reflective of the fact that Bowl Canada extended the YBC age so we did not gain those new members as they elected to continue with the YBC and our Rookie Tour. However, overall the impact of declining YBC numbers will affect our future.

This past season, we implemented a change to the Master Youth Events and it appears that it met its mandate and allowed both bantam and juniors to continue to compete with the Masters. As we move forward, we look to continue to partner with youth bowling programs to allow these events to continue.

Our big project this year has been with our voluntary disclosure to Revenue Canada regarding the GST/HST. As a non profit organization, we are not responsible for corporate taxes but we do need to collect GST/HST for the government. We have sought guidance on this in the past and have had conflicting advice as to whether to proceed or not. However, with the implementation of the HST, we once again reviewed this with other sport associations and it was recommended that we proceed.

Dave and Ashleigh (our marketing student) worked hard to ensure that we gathered as much information as was available to submit to Revenue Canada in order to rectify our status. Unfortunately, this did come at a cost for back GST/HST owed but in going forward, the proper procedures have been put in place to ensure that we can properly track and record this information.

This summer, the board will meet to review our goals as they relate to Membership, Liaising with other groups, Operational processes and tournaments.

The idea of amalgamation of the teaching and tournament divisions has been discussed. At this time, we have a nice problem in that our membership participation at our events would make this difficult due to the number of lanes required. However, we need to remember that the two groups also bring their uniqueness to the table in that some bowlers wish to play on a pins over average basis, some a scratch basis and some enjoy bowling their 6 games and some prefer some kind of playdowns or tournament formats. At a national level, we need to also continue to support the tournament and teaching participants that compete for national honours. However, amalgamation is something that remains on our minds and we will need to continue to monitor it going forward. You will see that there are a number of motions on the floor today that are providing an opportunity to move towards more events where we are playing as one. However, we need to note that one of the largest barriers is the fact that we as members need to respect the other division members and what they bring to the table. Part of this respect includes comments that are made in the various social media mediums. We need to remember that we need to conduct ourselves in a professional manner befitting a Master Bowler in our interactions with each other and the public.

Dave and Brenda Walters continue the process of auditing our tournaments and we have a decrease in receivables. We offer you a review of the tournament finances today and in going forward, we will continue to endeavor to produce a tournament summary at each subsequent tournament event.

Our Sponsors are a big part of our game and we wish to thank Don Walker and Pla Mor Bowl who came on board this year with the Dorothy Walker Memorial tournament and Jonathan Piche and Orleans Bowling Centre in Ottawa who sponsored the Eastern Classic event; Jeff Chaplin of Jeffrey Allan and Associates who provides us our jewellery and awards and is the sponsor for this Year End Event on the tournament side; Nith Valley Construction who sponsored our 1st tournament division stop; Echo Bowl for their sponsorship of the Western Ontario event; NEBs for their support of the New Years Classic and Master Senior events; Phipps Bowling and Softroll for their sponsorship of our Master Youth Events; Brian Lavoie of Parkway Bowl for their sponsorship of the Bursary tournament, Special Olympics Ontario, Anna Swartzman and Shoppers Drug Mart for their sponsorship of the Special Olympics event; Sanders Pro Distributing who provide us with a pair of shoes each year, and The Down Syndrome Association and Bowling Sales of Canada who paired with us during our zone youth roll offs.

This past season, we saw the departure of Mike Bates from the board due to work commitments that prevented him from providing the time and effort he felt was required to be a part of this board. Mike was a long standing member of our board and his efforts on this board as Vice President and Treasurer and most recently as Co Chair of the 2008 Nationals in Hamilton are to be commended and emulated by those currently on the board or those seeking to become a board member with todays elections. We thank him for the time and effort he has afforded this association and allowed us to become what we are today.

Steve Williams will also be stepping down after being on the board since 2000 also due to work commitments and we would like to thank him for his efforts with this board and association, including his time as treasurer. He also plays a big part behind the scenes with some individual masters and we are appreciative of this as well.

As we look at todayos agenda and the motions that have been put forth, it has come to the boardos attention that we need to do a better job in educating our members and zone delegates as there are a number of motions that are requesting things we already have in place. So as we move through todayos agenda, hopefully we can enlighten all of our members. You will also see that there are a number of motions on the same topic and when we get to them, we would like you to consider all the motions for that topic before you decide how best to proceed.

We are pleased that we have a number of people interested in running for the board and in working on behalf of the association. You will have some big shoes to fill as being a Board Member is not an easy task as it is time consuming, but if you have the passion and are willing to commit your time and efforts to this board, you will represent the membership well and allow the MBAO to sustain itself.

In closing, we the Board value your input, questions and thoughts. Again, thank you for attending this AGM as we the board share your interest in the MBAO. We work on behalf of you the members and we hope that the decisions that we have made this past season as well as the ones we will make today will strengthen our Association. We will continue to endeavour to work on the areas of Membership, Tournaments, Liaising and optimizing Operational processes. We as members of the MBAO must continue to be ambassadors for the game and our own association. We need to market our association and what it offers the 5 pin bowler who wishes to compete with other 5 pin bowlers on a regular basis throughout the bowling season. In short, we need to market ourselves.

2. Presentation by Down Syndrome Association of Ontario Walter Heeney

We partner with the Down Syndrome Association for the Master Youth Events. We will present a cheque to the Down Syndrome Association as a result of that. 18 Down Syndrome Associations will benefit from the monies raised. A speech therapy camp will be run during the summer. We are dealing with children ages ten and older. There will be a parents meeting in mid June. In July we will be running three programs:

July 11-12 Pottery July 18-19 Woodworking July 25-26 Bowling

During the Monday and Tuesday activities we will be giving out key words and phrases. On Wednesday and Thursday participants will prepare a speech for Friday. On Friday, there will be an evaluation of the presentations, with assistance and suggestions offered.

The Durham association will be looking for 16 instructors for their mini bowling camp. The annual conference will be held at Great Wolf Lodge in Oct and bowling and our contributions will be acknowledged there.

Nevada Ticket Sales. Walter noted that we have begun a partnership with the Lifesaving Society of Ontario with respect to Nevada tickets. They have a license for them in Ontario and our partnership will be to secure locations for ticket sales. For each location we will receive a one time finders fee of \$500.

3. Coaching update . technical review

Dave Johnson

The coaching courses are run through C5PBA and the O5PBA. They are handled and structured through them. Our involvement is in running the course and getting the manuals and other information out to the course. The money flows through the Masters and we order and pay for all of the materials used in each course. The community coaching and competitive coaching courses now take the place of the old level 1 and 2. There has been 1 competitive course held this year. For this new program a coach takes the course, and upon completion they are considered to be % rained + but not yet certified. From this course the Coach is assigned the task of developing a lesson plan to teach a skill in 5 Pin Bowling. The skill needs to be clearly defined and the plan on how to teach this skill is part of this lesson plan.

The coach must also take the Making Ethical Decisions+online evaluation found on the Coaching Assocaition of Canada website.

After at least 3 months of taking this course and the MED evaluation, the Coach can then apply for evaluation of their lesson plan. The plan and proof of having taken the online course are sent to the Ontario 5 Pin Bowlers Association for grading and approval. Once this is done an evaluator from the O5 will contact

the coach to have them set up a practice where the evaluator can come and witness the practice. Once this is completed the evaluator will review everything with the coach and recommend them for certification.

Coached are certified for 5 years. They will need to be re-evaluated after 5 years. Presently there are 2 people from the Ontario 5 Pin Bowlers Association handling the information and evaluations.

We only handle the course material, money and certificates.

For this year only the O5 has granted the people who took the competitive course this year the ability to coach at an national level before they are fully certified. We have done the same thing with allowing people to coach at national level for master for this year only.

Question from the field: Why do we allow the O5 govern us? Answer: The O5 is the governing body and the grants are through them.

Question: If you already have your level 2 do you have to do anything? Answer: Yeső you will have 3 years to take the evaluation portion. The competitive coach certification only lasts 5 years.

There is a flow chart about this which we will try to put on our website.

No Nicknames, proper names only No larger than 2 to 2 ½ inches in height

Discussion: Mitch would like to point out that duckpin standards are 3+which would be a big difference. Jeff Forester showed a duckpin shirt so that all members could see what is being talked about. We currently allow the name on the sleeve. This is at bowler cost. You could arrange it through the MBAO. You can put it on the official Youth event shirts as well.

Fraser amends the motion to change the size to 2 1/2 to 3+in height. Sandi and Elaine are in support. 6 opposed x Carried Defeated Withdrawn

<u>MOTION</u> : Name is allowed on players shirts. No restriction to size, colouring, and font designs. Will be at bowlers cost.

Angelle – we have a hard enough time getting people to follow the dress code now. We will not look like a professional organization. Alex – the colour for Ontario is powdered blue. We need to find a shirt that is accommodating and inexpensive to replace. Janet – supports having a comfortable shirt for all tournaments other than youth events. She supports a uniformed shirts for the youth events. Brandon- there are already a few different style of youth shirts now. We don't look uniformed.

MOTION: If the current format for the Master Youth events is to continue, we would like to see medals provided for top Junior Boy, top Junior Girl, top Bantam Boy and top Bantam Girl for each scratch division. This is to allow the bantams to have an opportunity to win medals as well as Juniors.
Mark Cote is alternate and can speak on the motion. Mark – it gives the kids a level playing field. Brenda P noted that this is the way you should run it, bantams compete against bantams, juniors against juniors. We already do what this motion asks. Carried Defeated x Withdrawn

MOTION: One of the Master Youth Tournaments should be scratch at both levels Bruce amends – at one of the Master Youth Tournaments events, the YBC kids who qualify as scratch should bowl scratch at every level. The master still competes as POA. It is confusing to scratch kids who qualify as scratch but then bowls POA at the next 2 levels.
Bruce suggested that we look at the first event. Changed to recommendation.

Al. the problem they are running into is the same as above. Kids who are qualifying as scratch are getting confused when then bowl POA at the next level. Pick one or the other and make it the same all the way through. Brenda P. donq we cover off the scratch player with the individual awards. Steven M. individual awards are great, but the team has a harder time to move on to provincials.
Fred K . all kids at the fall youth qualify as scratcho so they all move on to bowl POA at the next round. Brenda P . the motions are contradicting. This was the first year for the format. We are trying to accommodate both scratch and Poa. Program directors are already confused. When the board creates a tournament we like to leave it as for 2-3 years.

Tim O – we seriously should look at this. The youth are our base, with the declining base, we will continue to lose members. It should be a recommendation.
