1. Welcome / Introductions - President's Report

Thank you for attending this morning and for your ongoing input with our association. The 2015-2016 season marks the MBAO's 51st Anniversary. This season began with the loss of our long time tournament director Henry Fehr. Henry passed away over the summer and his loss has been felt by everyone in our organization. Jim Head and Andrea Freiday have stepped into the roles of tournament director at our various events. We thank them for their service over the year in running our many events. We pride ourselves that our events are run in a professional manner and this begins with the work of Dave Johnson, our Director of Operations in the office and continues with our Zone Delegates and the various tournament staff we utilize throughout the season. Our programs would not be as strong without these individuals and we are grateful for their efforts on behalf of the MBAO

We continue to partner with Jeff and Tom England, the owner of NEB's Funworld their Club Tour. Our Tournament Division was required to play at least one of the Club Tour events for aggregate, and all of our members have the chance to play the Club Tour events, and if they play in uniform, they have a chance to win an MBAO ring.

Our membership overall this season is down 9 members over last season. The continuing closure of bowling centres over the past few years, as well as the decline in Youth Bowlers appears to be the main reasons for this decline. Fortunately, many of the members affected by these closures and declining YBC programs are choosing to participate with the MBAO as unaffiliated Masters. We also saw several new members join, which seems to be a reflection of the quality of tournaments we are running. We are maintaining these excellent programs and looking at new ways to keep encouraging new members to join. Our Tournament Committee is currently working on next year's schedule. We have many dates and centres still to be confirmed. We will post a tentative schedule as soon as possible on both our MBAO website, as well as on our Facebook page.

Our MBAO Group Facebook page continues to evolve, and we are at 484 members now. We are using this page to post reminders of upcoming events, messages that we need to get out to our membership quickly, as well as to post initial results from our various events.

Our Elimination Draw continues to be our largest fundraiser. In the 2014-2015 season, our elimination draw sold out for the second year in a row. This season, we hope to duplicate that success. We would like to take this time to thank all of our members for their support of this draw. We still have a handful of tickets left to sell, so if you would like to purchase one, please see Elaine.

6. New Business:

Dave updated the membership regarding the status of the MBAO office: In April 2015 the Sport Alliance of Ontario declared bankruptcy and left all amateur sports uncertain about our offices. The SAO were subsidizing our rent through grants that they were receiving from the Ontario Government. In Sept 2015 the property owners and property managers agreed to extend our subsidized rent until June 2016.

We currently pay \$300.48 for monthly rent which is \$18.00 per square foot. As well we pay \$61.50 for telephones and internet and \$51.00 for parking. Total monthly amount is \$489.27 per month not including long distance charges. Nobody knows how to figure out how to charge the sports for long distance.

The sports were left with very uncertain futures and a steering committee was formed. This committee have been looking for new locations as well as negotiating with our current landlord for a new lease effective July 1, 2016. As of last week, April 28^{th} , 2016 we have not settled on either a new location or a new lease. The general thought now is that sports will now stay on a month to month basis but the monthly costs will increase. O5 were recently told to expect an increase of 30-50%. This temporary month-to-month lease would last until such time and a new lease or new location has been chosen and approved by those sports who remain at the former SAO building.

With this in mind, the Board of the Master Bowlers Association decided to physically move to a new location. We have done our own searches for suitable locations and a complete cost analysis in order to make this decision. We have been able to find a location within a storage facility that also rents out office space in Pickering Ontario. With this new location we have free parking and free internet. Our costs will be \$418 per month which includes an office and a storage locker plus \$30.00 for telephone which includes free long distance, giving us a total of \$448 per month and a savings of over \$41.00 per month based on our current rental rates. It is

expected the SAO rate will increase by at least \$120.00 per month so our savings are even greater. There is no long term lease at this new location; we are renting the space monthly so if another option presents itself, we are free to explore this. The risk is that costs may not be as stable as having a lease.

We will have some additional costs with this move where we will have to purchase our own copier, and moving costs. We may not be able to keep our current phone number but the address in Bowmanville will remain the same.

I believe that we have explored a large number of options and locations and this is the best possible solution that we could find which will keep our costs low and in turn gives us the ability to keep our membership fees stable for the future.

The Board of Directors and I share this information with you to explain why we are moving and hope you understand and approve of our decision.

- h. Discussion about inviting Quebec to play in our Orleans tournament RESPONSE: We took a poll at the last Orleans tournament to see if there were any concerns with us doing this; there was no negative feedback; seemed to be good support for doing this
- i. The Board shared that we would have a donation box at the bowling alley for anyone who wishes to donate towards the Red Cross for those who have lost so much as a result of the Fort McMurray fires
- j. What was the affect of changes to the Mid-Winter Blues? RESPONE: Looking to make further improvements to make things better at the Provincial level; it's possible we might put some zones together and have something similar to a mini-regional tournament but this would still be dependent on who shows up
