Fraser passed away on Monday. Watching post after post go on Facebook, and then seeing a page created to Celebrate his Life left me speechless. The page was created by a former player, who has not picked up a bowling ball for 20 years. This speaks volumns to the way that Fraser impacted the lives of everyone he met. Reading the stories that so many people across Canada posted made me smile. Fraser was an amazing competitor, a tireless volunteer and a friend to everyone he met. He will be missed.

The MBAO continues to run numerous events during the season in a professional manner and this begins with the work of Dave Johnson, our Director of Operations in the office and continues with our Zone Delegates and the various tournament staff we utilize throughout the season. This season also marks the 3rd year for both Jim Head and Andrea Disher as our Tournament Directors. Our programs would not be as strong without these individuals and we are grateful for their efforts on behalf of the MBAO.

Our membership is once again, down this season. As bowling centres across the province continue to close and as YBC numbers continue to fall, all bowling associations will continue to struggle with maintaining membership numbers. Our association is fortunate that many of the members affected by these closures and declining YBC programs are choosing to participate with the MBAO as unaffiliated Masters. We also saw some new members join, which seems to be a reflection of the quality of tournaments we are running. We are maintaining these excellent programs and looking at new ways to keep encouraging new members to join. Our Tournament Committee is currently working on next year's schedule. We have posted a tentative schedule of dates for next season around the room. Once the schedule is finalized we will post it on our website and facebook page.

Our Elimination Draw continues to be our largest fundraiser. In the 2016-2017 season, our elimination draw sold out for the third year in a row. This season, we hope to duplicate that success, although I fear we will fall

short. We would like to take this time to thank all of our members for their support of this draw. We still have tickets left to sell, so if you would like to purchase one, please see Christina. The draw will take place tomorrow here at the centre.

### 6. New Business (Motions/Recommendations)

a. BOARD MOTIONS APPROVED FOR THE 2017-18 SEASON
