MID WINTER BLUES EVENT - MBAO TEEN TOUR

(formally YBC Rookie Tour)

The Master Bowlers' Association of Ontario would like to advise you of the details for the current season's Mid Winter Blues MBAO Teen Tour. A general summary of the rules is as follows:

SCHEDULE OF EVENTS

Eligibility: Open to all YBC Senior bowlers.

Average Date: Bowlers will be using their MBAO TEEN TOUR average.

YBC Seniors who have not participated in any previous MBAO TEEN Tour events will use their YBC average as of December 31, 2023. New bowlers must have bowled

a minimum of (12) games prior to the average date.

Zone Roll-Off: All YBC Program Directors are encouraged to contact their

local MBAO Zone Delegate for roll off information. Zone Delegates have the option of hosting their roll off during January and February and must confirm their roll off date

to the MBAO Office by December 15, 2023:

MID WINTER BLUES TEEN TOUR - GENERAL RULES

- This event is open to all YBC Senior bowlers only. Bowlers will be competing along-side Teaching Masters at the zone round of the MBAO Mid Winter Blues in a completely separate event.
- 2. Averages used for this event will be the MBAO Teen Tour average. YBC Bowlers who have not established an MBAO average will use their YBC average as of <u>December 31st</u>, of the current season. New bowlers are to have bowled a minimum of twelve (12) games prior to the average date. Proof of average <u>will be required</u> and the average sheet must show all games bowled up-to-and-including the average date. Average sheets <u>MUST</u> accompany the registration form. Entries must be submitted to the local Zone Delegate by the established roll-off date.
- 3. This event will consist of a five (5) game roll-off. Qualifiers will be selected using a <u>Pins-Over-Average</u> format with all YBC Seniors (male and female) competing together in one division. Winners will qualify using the following formula:

| YBC Entries | Qualifiers |
|------------------|---------------|
| 1 7 Entries: | One (1) POA |
| 8 – 14 Entries: | Two (2) POA |
| 15 – 19 Entries: | Three (3) POA |
| 20 – 24 Entries: | Four (4) POA |
| 25 – 29 Entries: | Five (5) POA |

- 4. The entry fee for this event will be \$60.00 per bowler. YBC Seniors <u>will be required to pre-register for this event</u> with their local Zone Delegate or online at www.mbao.ca.
- 5. Substitutions at the Provincial Championships will be permitted prior to seven (7) days before the event except in the cases of extreme circumstances. A substitute bowler must come from the Zone Roll-Off and by going down the list of qualifiers in order of finish until a substitute is found. <u>All substitutions must be reported to the MBAO office along with the average sheets as soon as changes are made</u>. Prize money will only be paid out to bowlers who participate at the Provincial Championships.
- 6. It will be the responsibility of the YBC Program Director to confirm the location and time of their Zone Roll-off with their local MBAO Zone Delegate. A listing of all the Mid Winter Blues Roll-off Sites will be updated and posted to the MBAO website at www.mbao.ca on our Tournaments Menu / Zone Tournament Locations. YBC bowlers will be bowling alongside Master Bowlers during their qualifying round of the Mid Winter Blues.
- 7. Qualifiers will be competing for an opportunity to advance to the Provincial Championships scheduled for <u>Saturday</u>, <u>May 11</u>, <u>2024</u> at NEB's Fun World, in Oshawa. Registration will start at 9:00 am with a starting time of 9:30 am. Qualifiers will be competing for prize money based on the number of participants at the Provincial Final. The Provincial Final will be a five (5) game event with bowlers competing in this Pins-Over-Average event. All YBC Seniors will be bowling on the same lanes with the Master Bowlers for this event during both the zone roll-off and the Provincial Finals.

<u>DRESS CODE</u>: All YBC bowlers will wear a YBC-Identified bowling shirt or a plain golf shirt with a collar. "BLACK" pants/shorts (for men) and "BLACK" pants/skirts/shorts/capris (for the women). Cotton pants/skirts/shorts/capris will be permitted provided they are not faded, have no rips, tears or studs on them and have no slits up the side of them. Joggers, jeans, sweatpants, cargo pants, bike/exercise shorts are prohibited. No pants/slack/skirts/shorts/capris with external pockets on the sides will be accepted. Pants cannot have any sheer material.

<u>NOTE</u>: It is the policy of the Master Bowlers' Association of Ontario to request that all YBC Participants advancing to the Provincial rounds of any MBAO Events MUST complete a waiver form prior to bowling in the event. All YBC qualifiers will be issues this form after the local Zone Roll Off.

It would be appreciated if you could canvass your YBC Seniors for any interest. Those wishing to participate should be registered on the attached form. The completed forms, average sheets and entry fees should be sent directly to the MBAO Zone Delegate.
