### **2010 MASTER BANTAM TOURNAMENT**

The Master Bowlers' Association of Ontario would like to advise you of the details for the 2010 Master Bantam Tournament. Your past co-operation and dedication has made this event the huge success it is today. A general summary of the rules is as follows:

### **SCHEDULE OF EVENTS**

<b>In-House Qualifying Dates:</b>	<b>Two (2) weeks: January 30<sup>th</sup>, 2010 to February 7<sup>th</sup>, 2010</b>
<b>Average Date:</b>	
<b>For Bowlers:</b>	<b>Average as of January 24<sup>th</sup>, 2010.</b>
<b>For New Bowlers:</b>	<b>New bowlers must have bowled twelve (12) games <u>PRIOR</u> to January 24<sup>th</sup>, 2010, to establish an average. If the twelve (12) games are completed on January 30<sup>th</sup>, 2010 then the bowler will have the following week to qualify. If twelve (12) games are not obtained prior to February 7<sup>th</sup>, 2010, then they are not eligible to qualify.</b>
<b>Average Calculation:</b>	<b>All bowlers will be using their average as of January 24<sup>th</sup>, 2010. A new bowler's twelve (12) game average will be used to qualify and also to be used at the zone roll-off.</b>
<b>Zone Roll-Off:</b>	<b>Sunday, February 21<sup>st</sup>, 2010 – (3 games)</b>
<b>Provincial Final Date:</b>	<b>Saturday, March 13<sup>th</sup>, 2010 – (3 games)</b>

## **MASTER BANTAM – GENERAL RULES**

1. **Qualifying Age:** In order to be eligible to participate in the 2010 Master Bantam event, all boys/girls **must not be older than 10 years of age as of December 31<sup>st</sup>, 2009**. All affiliated Master Bowlers on the active membership of the Association are automatically entered in the event.
2. Each bowling centre qualifies a Bantam girl and Bantam boy for each Master Bowler from the centre (unless it is known prior to the qualifying round that a Master is unable to participate). A Bantam girl, Bantam boy and Master Bowler are then joined together as a team. Usually an arbitrary draw is used, but this is left to the discretion of the centre. **Once you run out of a gender, then the teams may be comprised of two (2) boys and/or two (2) girls.**
2. House qualifying rounds consist of two (2) consecutive bowling weeks and are to be completed by **February 7<sup>th</sup>, 2010**.
3. Qualifiers are selected on the basis of a **Pins-Over-Average (POA) first then Scratch format** using each of the two qualifying weeks separately. That is, high scores are posted from the week of January 30<sup>th</sup> - 31<sup>st</sup>, 2010 and then scores from February 6<sup>th</sup> - 7<sup>th</sup>, 2010 establish the qualifiers. As such, a youth bowler could bowl well one week and not the next and, with a high score, qualify for the event.
4. Averages used for the qualifying round will be as of **January 24<sup>th</sup>, 2010**. New Bantams must have completed twelve (12) games prior to January 24<sup>th</sup>, 2010 to be eligible for the first week of qualifying. However, if the twelve (12) games are completed on January 31<sup>st</sup>, 2009, these bowlers will be eligible for qualifying the weekend of February 6<sup>th</sup>, 2010 using their twelve (12) game average from January 24<sup>th</sup>, 2010.
6. Substitutes are not allowed for the Master Bowlers. If your bowling centre has exhausted all your Bantam boys and Bantam girls in accordance with Para 2 above, it is your responsibility to contact other centres in your zone to see if any Bantam bowlers are available. If Bantams are still not available, Master Bowlers are allowed to travel to another zones where they can participate with Bantam bowlers who are available in these other zones. Please contact both the Master Bowlers that don't have partners and the MBAO office to advise us of the situation. **Master Bowlers are allowed to play without YBC Bowlers if none are available in order to complete their aggregate eligibility.**
7. The zone roll-offs are scheduled for **Sunday, February 21<sup>st</sup>, 2010** and each Master will be advised of the location of this event. At this round, the format for the event will continue as pins-over-average and, all bowlers (boy, girl and Master Bowler) will bowl together in a **three (3) game team event**. Please confirm with the Zone Delegate that the roll-off information provided has not changed. You may also verify information on the MBAO website at [www.mbao.ca](http://www.mbao.ca).
8. **Average Verification – YBC Bowlers:** It is recommended that all YBC Program Directors ensure that the average sheets accompany their bowlers to the zone round of the Master Bantam so that all averages for the youths can be verified by the Zone Delegate prior to the event. **ALL WINNING TEAMS FROM THE ZONE ROUND WILL**

**BE REQUIRED TO PROVIDE AVERAGE SHEETS FOR THE YOUTH BOWLERS TO THE MBAO OFFICE PRIOR TO THE PROVINCIAL CHAMPIONSHIPS.**

9. **Tie-Breaker – Zone Roll-Off:** During the Zone Round of the Master Bantam, in the event of a tie for second or third, the tie will be broken by the highest POA in the last game. In the event of a tie for first place, **BOTH TEAMS WILL ADVANCE TO THE PROVINCIAL ROUND.**
10. The winning team(s) in each MBAO Zone will advance to the Provincial Finals, scheduled for **Saturday, March 13<sup>th</sup>, 2010** at Echo Bowl in Brantford, Ontario. The Provincial Finals will consist of a **three (3) game team event.** Registration will be at 1:30 p.m. and the event will start at 2:00 p.m. sharp.

**DRESS CODE: THE DRESS CODE FOR YBC BANTAMS AT THIS EVENT WILL BE A YBC- IDENTIFIED BOWLING SHIRT OR A PLAIN GOLF SHIRT WITH A COLLAR.**

**NOTE: IT IS THE POLICY OF THE MASTER BOWLERS' ASSOCIATION OF ONTARIO TO REQUEST THAT ALL YBC PARTICIPANTS ADVANCING TO THE PROVINCIAL ROUNDS OF ANY MBAO EVENTS MUST COMPLETE A WAIVER FORM PRIOR TO BOWLING IN THE EVENT. ALL YBC QUALIFIERS WILL BE ISSUED THIS FORM AFTER THE LOCAL ZONE ROLL-OFF.**
