#### SPRING MASTER YOUTH TOURNAMENT

The Master Bowlers' Association of Ontario would like to advise you of the details for this season's Spring Master Youth Tournament. Your past co-operation and dedication has made this event the huge success it is today. A general summary of the rules is as follows:

#### SCHEDULE OF EVENTS

In-House Qualifying Dates: Two (2) weeks: January 6th, 2018 to January 14th 2018

Average Date:

For Bowlers: Average as of December 31st, 2017

For New Bowlers: New bowlers must have bowled twelve (12)

games PRIOR to January 6th, 2018, to

establish an average. If the twelve (12) games are completed on January 6th, 2018 then

the bowler will have the following week to qualify.

If twelve (12) games are not obtained prior to January 15th,

2018, then they are not eligible to qualify.

Average Calculation: All bowlers will be using their average as of December 31st,

2017 for the house qualifying rounds. Bowlers averages will

be submitted as of January 15th, 2018 for the Zone and

Provincial rounds of this event.

#### **SPRING MASTER YOUTH – GENERAL RULES**

- Qualifying Age: In order to be eligible to participate, all boys/girls must not be older than 14 years of age as of December 31<sup>st</sup>, 2017. All affiliated Master Bowlers on the active membership of the Association are automatically entered in the event.
- 2. Each bowling centre qualifies one Bantam and one Junior for each Master Bowler from the centre (unless it is known prior to the qualifying round that a Master is unable to participate). This Spring Event will have a house qualifying round based on the YBC Bowlers average where the highest Pins Over Average during the qualifying weeks determine who is eligible to form the teams. A YBC Bantam, and a YBC Junior and Master Bowler are then joined together as a team. Usually an arbitrary draw is used, but this is left to the discretion of the centre. Once you run out of Bantams or Juniors, then the teams may be comprised of two Bantams and/or two Juniors. The Zone and Provincial Rounds are based on a POA Team Total.
- 5. House qualifying rounds consist of two (2) consecutive bowling weeks and are to be completed by <u>January 14<sup>th</sup></u>, <u>2018</u>
- 6. Qualifiers are selected on the basis of a <a href="Pins-Over-Average">Pins-Over-Average</a> (POA) format using each of the two qualifying weeks separately (NOT combined). That is, high POA scores are posted from the week one and then scores from week 2 establish the qualifiers in both the Bantam and Junior Divisions. As such, a youth bowler could bowl well one week and not the next and, with a high score, qualify for the event.
- 7. Averages used for the qualifying round will be as of their December 31st, YBC average of the bowler. Averages for the Zone and Provincial Rounds will be as of January 15th, 2018. New YBC Members must have completed twelve (12) games prior to January 7th, 2018 to be eligible for the first week of qualifying. However, if the twelve (12) games are completed on January 8th, 2018, these bowlers will be eligible for qualifying the weekend of January 14th January 15th using their twelve (12) game average from after January 15th, 2018.
- 8. Substitutes are allowed for the Master Bowlers by using an Unaffiliated Master Bowler who is willing to play. If your bowling centre has exhausted all your Bantams and Juniors in accordance with point 3 above, it is your responsibility to contact other centres in your zone to see if any Bantam or Junior bowlers are available. If YBC Players are still not available, Master Bowlers are allowed to travel to another zone where they can participate with YBC bowlers who are available in these other zones. Please contact both the Master Bowlers that don't have partners and the MBAO office to advise us of the situation. Master Bowlers are allowed to play without YBC Bowlers if none are available in order to complete their aggregate eligibility.
- 9. **Emergency replacement (Zone Round)**: In the case of emergency, when a master bowler is unable to bowl or does not show up on the day of the event, that master can be replaced by random draw from other masters of their same bowling center or if none are available, then the draw will include all masters from their same zone who are in attendance. The selected master will use their scores from the event so youth bowlers still have the opportunity to advance to provincial round. The replacement master would move on to the Provincials with that team if they win.

- 10. **Format for the Zone Round:** The format for the event will continue as pins-over-average and, all bowlers (Bantam, Junior and Master Bowler) will bowl together in a <a href="three">three (3) game team POA event</a>. Please confirm with the Zone Delegate that the roll-off information provided has not changed. You may also verify information on the MBAO website at <a href="https://www.mbao.ca">www.mbao.ca</a>.
- Average Verification YBC Bowlers: It is recommended that all YBC Program Directors ensure that the average sheets accompany their bowlers to the zone round of the Spring Master Youth tournament, so that all averages for the youths can be verified by the Zone Delegate prior to the event. <u>ALL WINNING TEAMS FROM THE ZONE ROUND WILL BE REQUIRED TO PROVIDE AVERAGE SHEETS FOR THE YOUTH BOWLERS TO THE MBAO OFFICE PRIOR TO THE PROVINCIAL CHAMPIONSHIPS.</u>
- 13. The winning team(s) in each MBAO Zone will advance to the Provincial Finals.

<u>DRESS CODE</u>: THE DRESS CODE FOR YBC PLAYERS AT THIS EVENT WILL BE A YBC- IDENTIFIED BOWLING SHIRT OR A PLAIN GOLF SHIRT WITH A COLLAR.

NOTE: IT IS THE POLICY OF THE MASTER BOWLERS' ASSOCIATION OF ONTARIO TO REQUEST THAT ALL YBC PARTICIPANTS ADVANCING TO THE PROVINCIAL ROUNDS OF ANY MBAO EVENTS MUST COMPLETE A WAIVER FORM PRIOR TO BOWLING IN THE EVENT. ALL YBC QUALIFIERS WILL BE ISSUED THIS FORM AFTER THE LOCAL ZONE ROLL-OFF.
